#### ■ Minutes

#### Evaluator Roster

• Each Regional Rep will take half of their Region and prepare a current list of Evaluators, weaning out those who have expired. We will then compile a complete list at the April meeting. Those who haven't evaluated within the two--year period will be granted a grace period in which they may SHADOW by the end of 2003 to retain their status as an Evaluator.

#### □ International Rescue Dog Symposium

• Ann W. will be speaking at the above symposium in Prague at the end of April, along with Isa Kuhn and Ben Ho. She will give an update on the FEMA Canine program and the K9 response to the WTC on 911.

### Starting Route on Type II

• The Evaluators are responsible for the test set-up and thus must have some flexibility. The testing Handler should not be given a specific route to send his dog, but may be advised of areas that are "off-limits". The Handler is responsible for working his canine in a safe and efficient manner given the information supplied.
