  - Discussion per evaluator calls:
  - Discussion: The CSC will proceed down the course that we have outlined with the new evaluator controls vs a major revision of the DSCREP. This should help maintain consistency amongst evaluators.
- Mentor Applications:
  - o Julie Noyes-CO-TF1
- Shadow Progress Chart
  - Tracy McDonald-TN-TF1, Type I handler approved to begin evaluator process
- New Evaluators
  - o Jennifer Little-VA-TF1, Handler
- Shadow SOPs-
  - No more than two at a time on rubble
  - o Rotate on rubble
  - Written test (needs updating)
  - Review DSCREP at the beginning
  - Debrief afterwards with them
  - Review their comments
  - Need a Shadow Mentor job description(?)
    - Can we require this to be a position every time?
- The PFD that was recommended by the CSC is:
  - o C.F.D." #2140L manufactured by NRS--Northwest River Supplies

- Questions from Handlers:
  - o "Do you have to do the stop/turn on the obstacle on the first attempt?
    - No, they are independent of each other. You can stop and turn on any obstacle at any time. You can even fail the obstacle and pass the stop/turn
  - "Why at some tests are handlers not allowed to reward until the rubble in Type II?
    - There are no toys allowed in the test area. The chief will designate where you can designate your dog in between the elements. The setup of the test will determine this.
- MO cert prep—ready to go.
- 2006 evaluation Budget:
  - Number of test days should be reduced with elimination of Type 2 testing.
- 2006 Test schedule to be determined in August
  - o specified months will be the cert preps
- Discussion: number of evaluators per site with roving Chief and a QA rep from CSC/SWG at each test?
  - [Secretary's note: Subsequent discussion resulted in keeping the nine evaluators, plus a roving Chief. CSC/SWG QA may be cost prohibitive]
- Two evaluators for the FSA
- Discussion: Tighten up agility?
- Agility—wobbly surface
  - Suggestion: Take four saw horses that are 3 feet high. Place a 4' x 8' sheet of plywood on top of the saw horses and you can pile on different debris items not to exceed 2' in height.
- Discussion: ladder-do we make the ladder a flat rung?
  - o If standarizing ladder, make it the ladder in the cache
    - 8' little giant ladder (Cathy will get a description to CSC)
    - Put in next revision, if the test of it has good results
- Discussion: Emergency Stop
  - Will revisit at the next DSCREP revision
- Discussion: Redoing obedience skills
  - Will revisit at the next DSCREP revision
- Evaluator Groups: To be determined
- Single Certification Evaluators
  - One FSA evaluation every two years
  - One Type I evaluation every two years
