#### 2) June CA-TF2 Certification Evaluation

Test went very well - the only "issues" were minor orginzational items. CE was conducted on day one and a CP was conducted on day two. Clean pass/fails. There were no issues with the teams that did not pass the CE. There were 7 dogs at the CP and it went well. It was suggested that we incorporate into SOPs, a post-evaluation conference call with the evaluators, sub-group and canine coordinators. This will be added to the agenda for the face-to-face.

### 3) Suggestion from Evaluator

On Limited Access site—give the handler the 5 foot area away from the victim, so as to ensure victim's safety, i.e., the handler won't be standing on top of the victim.

CSG discussed, but decided to leave the parameters as written. The victim's safety must be ensured, the hole must be safe, even if someone is standing on top of him.

This led to a discussion of victims in general—using children, etc. There are no set parameters. Different TFs have different rules, according to their local regulations. We will keep tabs on this issue and bring it up to the Canine Coordinators.

## 4) Search Working Group Meeting

- Most of the meeting spent on the search definitions. The definitions are being revised in conjuction with input from other agencies, i.e. Coast Guard, etc. with the intent of getting everyone in SAR on the same terminology page. Teresa will forward to the rest of the group when they are close to being finalized.
- Medical specialist training video that Lori Gordon created was enthusiastically accepted by the MWG.
- Recon robot—demo of a low flying robot that "sees", "hears" and can monitor hazmat over collapsed structures and voids

### 5) 2008 K-9 Needs

• Two calendars will be proposed to fit possible high/low funding.
