# Disaster Canine Combat Challenge

July 20-22 Baltimore Maryland

On the weekend of July 20<sup>th</sup> – 22<sup>nd</sup> Search & Rescue Assist, Inc. and Hydrolyte held the first ever Disaster Canine Combat Challenge. All Task Forces were invited to send a participant with the potential opportunity to send two. Fourteen handlers stepped up and accepted our challenge to strut their stuff! We had a very well rounded representation with teams from California, Washington, Nevada, Ohio, Colorado, Virginia, Maryland, Florida, Massachusetts and Pennsylvania. Someone up there must love us because instead of the normal upper 90's with high humidity we had 80's and low humidity. Very unexpected but I don't think anyone complained!

The first day saw all handlers participating in Obedience, Dexterity, Rubble and Area Searching. The second day saw the top 50% go on to a realistic, scenario-based search.


We used the International Rescue Organization's obedience routine which is also part of a Schutzhund obedience routine. The handler was responsible for performing the pattern correctly without guidance from the judge. While this was the challenge that worried handlers the most, no

one died during this portion of the weekend. All teams started with 50

points.



Next all teams went on to the Dexterity Challenge. This is the international term for agility. All teams started this event with 50 points. We incorporated the help of some very demented handlers to think of some really fun combinations and it was a huge success. The dog started out by climbing into a large corrugated metal pipe (at ground level) that led up to a 10 - 12" platform. From there the dog had to climb down a chain link panel onto another platform and then climb down a wooden ladder.



had to go left on that prop. #5, the last challenge was a large black plastic pipe which was hanging from scaffolding by rope. The dog had to jump into the pipe from the ground, go through to a platform and then cross a

15' round rung aluminium ladder set

From there all teams went to full access rubble search where anything was game and they had 10 minutes to search. Teams started this with 100 points.





Next each team went to our "Tornado" scenario. All teams started with 100 points and had 20 minutes to conduct an open area search. We used a "leap frog" access, so the judges could see direction and control as well as handler strategy.





By the end of day one, we were all hot, tired and thirsty but everyone, no matter what their standing, was enthusiastic and ready to see what was in store for the seven handlers (top 50%) that made it to day two! We all met at the fire hall for drinks, debrief, food and some great conversation!







Sunday consisted of just one challenge worth 300 points: EQ - Main Street Scenario –Full Access – 40 Minutes

This scenario consists of all areas within the banner tape to the fence and ending at drop off area.

This EQ, Magnitude 7.2 occurred at 0730 on Friday morning. The search area consists of 3 structures; a new apartment building, a storage company and a lumber yard.

- Hailing has been done, and surface victims removed.
- Structural Spec grant full access, with caution, any areas off limits will be taped off
- HazMat is clear
- Debrief your findings to the Escort Judge

The July heat made efficient strategy critically important. The search area consisted of 2 rubble piles, a couple city buses and a large pallet pile as well as all the area in between. A viewing stand was built right in the middle of the area so everyone had a bird's eye view of this challenge!

Everyone was challenged but more importantly everyone who attended learned a lot!





The event received a tremendous amount of positive feedback. The weekend was a huge success and I owe a debt of gratitude to the *MANY*, *MANY* volunteers to spent so much time carefully planning every detail and then came out for the weekend to make sure everything went as smoothly as possible. Handlers from several Wilderness Response teams as well as our friends and relatives were instrumental in making this happen.
