Texas Task Force One (TX-TF1) is hosting a National Urban Search & Rescue (US&R) Response System (the System) Canine Search Specialist Certification Evaluation (CSSCE) in College Station, Texas on October 18th and 19th, 2014. There will be no registration fee for this evaluation. Task Forces will be responsible for their members' travel, lodging and per diem expenses. The CSSCE is open to System candidates who have passed an FSA and are seeking to certify, or re-certify, as FEMA Canine Search Specialist Teams.
